## E. M. Singleton named senior consultant for transition

Former Coastal Chancellor Edward M. Singleton has been named senior consultant to the Coastal administration during the college's transition from a USC System campus to an independent, state-supported institution.

Interim Chancellor Ron Ingle said he asked Singleton to assist in the process because of his 30-year relationship with the institution and his knowledge of the community.

Singleton led Coastal from 1963 through 1983. During his tenure as chancellor, Coastal underwent steady growth from a single-building campus with about 100 students to a campus with nine major buildings and more than 2,500 students at the time of his retirement in 1983.

Singleton maintains close ties to the college. From 1983 to 1989, he was Commissioner of the Big South Conference, in which Coastal's athletic teams participate. He is a member of the Coastal Educational Foundation, Inc., the private, non-profit support component for the college. The University of South Carolina Board of Trustees named Singleton Chancellor Emeritus upon his retirement. ~

### • School of Natural and Applied Sciences

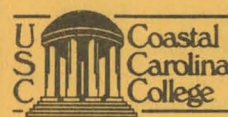

## GCE to host conference on education

Coastal will host "Weaving a New Vision for Education," a special, two-day conference for educators featuring topics such as restructuring education, whole language, racism, and children at-risk, Friday, Oct. 23 and Saturday, Oct. 24.

The conference features concurrent sessions and keynote addresses Friday from 1:30 p.m. to 6 p.m., and Saturday from 9 a.m. to 1 p.m.

Conference participants will have opportunities to talk with other educators and administrators involved with using the conference topics.

Keynote speakers include Crystal Kuykendall, Anisa Kintz and Janet Files.

Author of the acclaimed book, *From Rage to Hope: Strategies for Reclaiming Black and Hispanic Students*, Crystal Kuykendall holds doctoral degrees in education and law. She is a former primary, junior, and senior

high school teacher. Kuykendall has served as executive director of the National Alliance of Black School Educators and was appointed by President Carter to chair the National Advisory Council on Continuing Education.

Anisa Kintz received national media attention in January 1992 when she organized "Calling All Colors," a race unity conference at Coastal for children that attracted 100 registrants in the third through eighth grades. She was nine years old when she was named President Bush's 750th Point of Light in April 1992.

Janet Files is a teacher, author, and speaker in the fields of whole language, teacher collaboration and children at-risk. She is the director of Coastal Writing Project.

## Four-day wetland delineation course set

The Center for Marine and Wetland Studies is offering Basic Wetland Delineation, a special four-day course to be held Thursday, Sept. 24 through Sunday, Sept. 27. The non-credit course is \$450. Registration deadline is Monday, Sept. 14.

The course is a combination classroom and field program designed to provide a basic understanding of current regulatory and technical criteria used by the U.S. Army Corps of Engineers in determining jurisdic-

Equipment and transportation to the field will be provided; however, participants are responsible for meals and lodging. ## Coastal Carolina Alumni Association names Alford Alumnus of the Year

The Coastal Carolina Alumni Association has named William "Billy" Alford the 1992 Alumnus of the Year. The association annually honors an alumnus who has distinguished himself or herself as a leader in his or her profession, as well as civic, community and alumni activities.

Alford earned a bachelor's degree in political science in 1977 from Coastal. A fire restoration contractor, Alford also is chairman of the South Carolina Department of Highways and Public Transportation Commission.

He was a member of the Horry County Higher Education Commission (HCHEC) from 1985 to 1989. Alford is chairman emeritus of the commission. Formed in 1959 by the General Assembly, HCHEC is accountable for the county tax millage to the college. HCHEC provides funding for scholarship assistance, capital improvements, faculty and staff development, and supplementation to educational programs. In addition, the commission formed and supports Coastal's four resource centers.

Alford has been a member of Coastal Educational Foundation, Inc. (CEF) since 1989. CEF is a non-profit organization which provides resources to Coastal for scholarships and for

meeting student and faculty needs not supported by state allocations. In addition to its fund-raising activities, the 20-member CEF board promotes and interprets the institution in the community.

Alford was a member of the board of directors for the Coastal Carolina Alumni Association from 1979 to 1981, and served as president in 1980-1981 and chairman of the board in 1981-1982.

His numerous community activities include Myrtle Beach Area Chamber of Commerce, Leadership Grand Strand, Leadership South Carolina, ODK leadership fraternity, Rotary Club, and Area Council on Transportation. Alford is also chair of the board of trustees of Grand Strand General Hospital.

He was named Citizen of the Year of Myrtle Beach, *The Sun News* Honor Volunteer in 1985, and Outstanding Young Men of America in 1985. In 1990, he was named Who's Who Among Rising Young Americans.

Alford is married to Dawn Marie Snyder Alford; they live with their two children in Myrtle Beach.

Clark Parker, HCHEC chair and Coastal alumnus, presented the award to Alford at the association's annual meeting June 30. ~

## HCHEC establishes Trout Scholarship

The Horry County Higher Education Commission has approved the Thomas J. Trout Scholarship as a tribute to the late Distinguished Professor.

Trout joined the Coastal faculty in 1973 as a professor of English and chaired of the Department of English from 1982 to 1992. He earned a bachelor's degree in history from Denison University in Granville, Ohio in 1943. After a successful retail and civic career in Findlay, Ohio, Trout earned a master's degree in American studies in 1970 and a Ph.D. in English in 1972, both from Bowling Green State University in Bowling Green, Ohio. In addition to Coastal, Trout taught at Bowling Green State University and Findlay College. He died May 29, 1992.

The \$1,000 annual scholarship will

be awarded to a rising junior who is majoring in English. The scholarship is renewable through the recipient's senior year providing eligibility requirements are met. The scholarship recipient must be a full-time student and maintain at least a 3.0 grade point ratio. Selection of a recipient by the USC Coastal Carolina College Scholarship Committee is determined on the basis of individual motivation toward higher education and potential for academic achievement. Preference for the scholarship is given to applicants from Horry County.

**Carole Nichols** was chosen as one of five state outstanding volunteers by the South Carolina Department of Mental Health. She works as a volunteer at Conway's Progress Place. This facility is home to many of our area's chronically mentally ill. The award was made in Columbia on July 14.

**Ernie Locklair's** article "Wandering the Waterway" was published in the July-August 1992 issue of *Pee Dee Magazine*.

**Richard H. Moore** has contributed a chapter entitled "Low Salinity Backbays and Lagoons" to the book, *Biodiversity of the Southeastern United States: Aquatic Communities*, published by John Wiley & Sons, Inc. **Susan Libes, Joann Pugh, and Prashant Sansgiry** have been selected to participate in a National Science Foundation-funded project designed to increase the participation and retention of women and minorities in math and science degree programs.

The two-year study involves the entire University of South Carolina system. The participating faculty will be developing new teaching and assessment methods. These techniques will then be presented to the rest of the faculty. The principal investigator for the project is Sue Rosser, director of Women's Studies at USC Columbia.

**Karen Carpenter, Janis Chesson, C.C. Edwards, Susan Libes, Betsy Puskar, Prashant Sansgiry, Jill Sessions, and Susan Shepherd** attended a women's study conference from May 29 to June 1 at the University of North Carolina in Chapel Hill. The conference, entitled "What Difference does Difference Make?," explored how multiculturalism can be integrated into traditional feminist studies.

**C.C. Edwards, Susan Libes, and Prashant Sansgiry** were selected to attend a three-week workshop on supercomputing, conducted from May 17 to June 5 at the North Carolina Supercomputing Center (NCSC) located in Research Triangle Park, N.C. The team from Coastal was the only group from South Carolina selected to participate. The goal of the workshop was to explore ways that supercomputing can be integrated into the undergraduate science and math curriculum. These faculty members were chosen because they are developing a new course in computer modeling that will be taught in the fall of 1993. As part of the workshop, the faculty were each granted \$5,000 worth of computing time on NCSC's Cray Y-MP. NCSC's machines can be accessed from Coastal through Internet, a national computer network. Class and Faculty Familiarization accounts are available. Contact one of the participants for more information.
