COASTAL TREATS AREA TO SHAKESPEARE FESTIVAL

The highly acclaimed Alabama Shakespeare Festival will perform Shakespeare's popular Twelfth Night in the second event of USC-Coastal Carolina College's 1979-80 Cultural Arts Series, Monday night, November 5th at 8 PM in the new Conway High School Auditorium. Tickets at the door will be \$3.00 a seat or patrons may purchase season tickets for Twelfth Night and three other performances from the college at a reduced rate.

"If there was any skepticism about a professional Shakespeare company from Alabama," wrote the Lafayette, Louisiana Advertiser, "it was easily dismissed by the audience...It was a bold and brilliant performance...that gave one the feeling that perhaps this was the way Shakespeare always intended his play to be performed."

Twelfth Night, the Alabama Shakespeare Festival's performance for the Coastal Carolina College Cultural Arts Series, centers around identical twins, mistaken identity, romance, comedy and melancholy.

The Cultural Arts Series is sponsored by Coastal Carolina College, the National Endowment for the Arts, the Southern Arts Federation and the South Carolina Arts Commission.

Although tickets for all performances may be purchased at the door, reduced season tickets are available at Coastal Carolina College with season prices at \$9 for non-students; \$6 for senior citizens and Community Concert members; \$5 for students, faculty or staff of any school and \$4 for Coastal Carolina faculty, staff or students. Season tickets may be used for all four remaining performances.

SOLICITATION AND DISTRIBUTION

South Carolina Code of Laws, Volume 4, Section 8-11-230, sets forth the Policy on Solicitation and Distribution. The University of South Carolina, as an employer, is legally responsible for promoting the efficiency of the public service it performs. The following rules are promulgated in futherance of that legal responsibility:

- Solicitation or distribution of pamphlets, products, or other materials by persons other than employees and students of the University in those areas of the University which are not open to the public is prohibited. Solicitation or distribution by persons other than employees and students of the University which are open to the public is prohibited.
- Solicitation in conjunction with non-University sponsored activities by University employees on University property during working time is prohibited.
- Distribution of pamphlets, products, or other materials by University employees on University property in nonworking areas during working time is prohibited.
- Distribution in conjunction with non-University sponsored activities of pamphlets, products, or other materials by University employees on University property in working areas is prohibited.
- 5. Charitable fund drives approved by the President may be conducted under the University's supervision.
