Commencement exercises to be held

Coastal Carolina University will graduate approximately 375 students during commencement exercises Saturday, May 7 at 10 a.m. at the campus soccer stadium. The public is welcome.

In case of inclement weather, the commencement ceremony will be held in Kimbel Gymnasium; a closed-circuit broadcast also will be shown in Wheelwright Auditorium. Rain tickets for admission to the gymnasium will be issued to degree candidates prior to rehearsal Friday, May 6.

Faculty members Ronald Lackey and Paul Stanton will deliver the commencement address.

Lackey and Stanton will both retire from Coastal Carolina University on June 30 after 20 years each of service to the institution.

Lackey was the first dean of student affairs when Coastal became a four-year institution in 1974. He served in this capacity for three years. Since 1977, he has served as associate professor of religious studies and university chaplain. Before joining the Coastal faculty, Lackey was dean of student affairs and part-time instructor at South Georgia College in Douglas, Ga. He has served as pastor in North Carolina and Virginia. He also has been interim minister at eight local churches and is affiliated with several national religious societies.

Lackey is a native of Chapel Hill, N.C. He received a Ph.D. in higher education administration from Florida State University in 1972, and a master of divinity degree from Southeastern Baptist Theological Seminary in Wake Forest, N.C., in 1963. From 1963 to 1964, he attended Duke Divinity School for post-graduate work. He received a bachelor's degree in psychology from Furman University in 1960.

In 1991, the Ronald D. Lackey Service Award was established in honor of Lackey for his dedication to campus

Awards for achievement presented during Honors Convocation

Coastal Carolina University honored top academic students and faculty members during the annual Honors Convocation held Tuesday, April 26.

The Academic Excellence Award recognizes outstanding academic achievement by a senior student. Selected by a faculty committee with representatives from each school of the university, candidates for this award must attain a minimum cumulative grade point average of 3.5, the endorsement of a faculty adviser, and a record of academic honors throughout their enrollment at Coastal.

The 1993-1994 Academic Excellence Award recipients are Michael R. Gibbs and Christine C. Shutter. Both recipients have earned a 4.0 grade point average during each semester of their

Coastal enrollment.

Gibbs is an accounting major from Surfside Beach. He is president of the student chapter of the Institute of Management Accountants — he served as the group's vice president last semester. He is the two-time recipient of the organization's scholarship award. Gibbs is a student government representative and a strategic planning associate for the Center for Economic Development housed in the Wall School of Business Building. He has been a three-time AT&T Collegiate Investment Challenge participant; a CINO Day assistant; a 1993 recipient of the S.C. House of Representatives Academic Achievement Award; a 1993 recipient of the S.C. Tax Council Scholarship Award; and was named to *Who's Who*

Shutter is a psychology major from Conway. She is a member of Psi Chi, the national honor society for psychology; was named to *Who's Who Among Students in American Colleges and Universities*; is a member of Omicron Delta Kappa leadership honor society; is a student government representative; was a psychological statistics tutor; is psychology club vice-president; and was the recipient of the Springs Bachelor of Science Scholarship for the 1993-1994 academic year.

The Ronald D. Lackey Service Award, named in honor of a faculty member and university chaplain, is given to a senior on the basis of conspicuous service to the university through involvement and leadership in campus organizations.

Andrew Stonefield, a biology major from Hingham, Mass., was presented the award by Robert Squatriglia, vice president for Student Affairs. Stonefield has held numerous offices in the Student Government Association including secretary and vice president. He has been president of the biology club; president of Alpha Phi Omega service organization; a Coastal Outdoor Adventure instructor; assistant secretary of the African-American Association; an orientation assistant; secretary of the international club; a S.T.A.R. community service intern; a member of Phi Sigma Tau philosophy honor society; and a member of numerous student/faculty committees.

The Coastal Educational Foundation Distinguished Teaching Award recognizes faculty who have demonstrated excellence in teaching. A student committee solicits nominations from students. Top candidates then receive classroom visitations and are interviewed by the committee.

The Distinguished Teaching Award was presented to Veronica D. Gerald. An instructor in the Department of English, Gerald joined the Coastal

faculty in 1982. She received a bachelor's degree in English in 1972 from the University of Maryland and a master's degree in English in 1975 from Atlanta University. She has participated in advanced studies at the University of South Carolina and Illinois State University. She is currently working towards a Ph.D. at Emory University in Atlanta, Ga. Gerald lives in Conway.

and community service. The award is presented annually to a Coastal senior who serves the university community through conspicuous service through involvement and leadership in campus organizations. The Student Affairs Committee screens applications and then allows university professors and departments to cast ballots for the nominee of their choice. The award is presented at the university's annual Honors Convocation.

Lackey received Coastal's annual distinguished teaching award in 1979 and has been a finalist for the honor five times. In 1988, he participated in the South Carolina Consortium of International Studies' China Fulbright project. He serves as president of the Furman University Alumni Association and spiritual director of the Seaside Emmaus Community. Lackey is an original board of directors member of Horry Mercy Hospice.

Paul Stanton, provost and professor of psychology, has been a member of the Coastal faculty since 1974. He was vice chancellor of Academic Affairs at Coastal from 1974 to 1979, during which time the college was approved as a four-year degree granting branch of the University of South Carolina. Stanton was instrumental in the establishment of 14 baccalaureate degree programs and the recruitment of approximately 45 faculty members during his term as vice chancellor. Today, Coastal offers baccalaureate degree programs in 25 major fields of study and master's degrees in education. There are more than 4,400 students and nearly 200 full-time faculty members.

Stanton has held additional administrative positions including dean of the School of Education at Lock Haven State College in Pennsylvania from 1972 to 1974 and chair of the Department of Reading and Language Arts at the University of Pittsburgh from 1967 to 1972. He held teaching, counseling and guidance positions in higher education and public schools from 1957 to 1967.

Stanton received a Ph.D. in counselor

education from the University of South Carolina in 1966, a master's degree in counselor education from East Carolina University in 1962, and a bachelor's degree in physical education and history from High Point College in 1957.

Among his many professional publications, Stanton is co-author of *Fun With Reading*, a series to assist parents in teaching reluctant readers to read. The book was published in 1991. He has been involved in many university-related activities and is a past recipient of Coastal's Student Affairs Division Award which honors faculty who have made significant contributions to the quality of student life.

Thurman Wilson Anderson, retired Horry County school superintendent, will receive the honorary degree of doctor of public service. Anderson attended Clemson and Furman universities and Newberry College; he received a master's degree in education from the University of South Carolina in 1959.

Anderson dedicated his life to education - beginning as a teacher, then principal, and a 32-year post as Horry County school superintendent. Through Anderson's leadership, Horry County's implementation of racial integration became a model for the state.

Before Anderson took office as superintendent in 1941, teachers in the county could not get college credit locally. Recognizing this need, Anderson was instrumental in the establishment of what is now Coastal Carolina University. Anderson attended a meeting at the Horry County Memorial Library on July 23, 1954 with a group of interested citizens to discuss the creation of a local college. When funds were needed to support the group's efforts, Horry County teachers were among those who donated to the cause.

Anderson has shown interest in Coastal Carolina University since its beginning and has served on numerous boards and committees throughout the years. He was a member of the Coastal Educational Foundation, Inc., from 1959 to 1964, serving as secretary from 1960 to 1963. He was a member of the Horry

County Higher Education Commission until 1970 and was presented a Founders Medallion during Coastal's first Founders Day Convocation in 1987.

In addition, S.C. Vocational Rehabilitation Department commissioner Joseph Sarvis Dusenbury will receive the honorary degree of doctor of fine arts.

Dusenbury received a master's degree in educational administration in 1953 and a bachelor's degree in education in 1950, both from the University of South Carolina. He has a permanent certificate as elementary teacher and principal, secondary teacher and principal, and superintendent.

Dusenbury has served as commissioner of the Vocational Rehabilitation Department since 1976, and is responsible for the statewide vocational rehabilitation program which provides a wide range of services necessary to rehabilitate individuals with physical and mental disabilities.

He began his career at the rehabilitation department in 1960. Dusenbury served as administrative liaison officer in the vocational rehabilitation department's state office from 1967 to 1968; area supervisor from 1966 to 1967; and as disabilities counselor from 1960 to 1966. He served as principal of Poyner Junior High School in Florence, S.C., from 1954 to 1960, where he organized the first area "ability groups" recognizing special needs of students with disabilities. He was principal of Royal Elementary School, also in Florence, from 1952 to 1954; and served as principal of Pinewood High School in Pinewood, S.C. from 1950 to 1952. He taught at Brookland Grammar School in West Columbia from 1949 to 1950.

He served in the U.S. Navy from 1943 to 1946.

Dusenbury has received numerous citizenship awards and citations for his work for people with disabilities. In 1991, he received President George Bush's Distinguished Service Award for work in the disability field. He was awarded the Social Security Administration's outstanding service award in 1990. ■

Karen Carpenter recently received grant fundings from two levels of Phi Delta Kappa, the professional fraternity in education, for her middle school program entitled "The New Women's Work: Alternative Careers for Women in Science and Technology." The 16 week program will begin in fall 1994 and involves all female seventh grade students at Whittemore Park Middle School. Phi Delta Kappa National Association funded \$850 and the Coastal Carolina University Chapter funded \$500.

Tim Touzel recently attended the 72nd Annual Conference of the National Council of Teachers of Mathematics held in Indianapolis, Indiana, April 12-16. He presented a paper, entitled "Portfolio Analysis in an Elementary Math Methods Class," which was one of more than 25 presentations on writing and alternative assessment in mathematics presented at the conference. This paper continues his research on written expression and assessment in mathematics classes.

Kathy Taylor and **Tom Kantz**, and biology majors **Karen Eyerly** and **Jeremy Wernig**, attended the annual meeting of the South Carolina Academy of Sciences held in Aiken on April 14-15. Eyerly presented a research paper coauthored by Taylor, entitled "Foraging preference of avifauna in three habitats in coastal South Carolina." Taylor presented a paper, coauthored by biology major **Deena White**, entitled "The effects of horse grazing on the plant community

composition and structure of a South Carolina horse ranch." Kantz served for the second year as judge of the student awards competition in molecular biology.

Ed Cerny presented a lecture at the 29th Annual Conference of the Potomac and Chesapeake Association of College Admission Counselors held in Norfolk, Va., April 25. He and Dana Law, director of retention for Noel-Lentz, spoke on the topic of retention. Cerny also was nominated for the American Advertising Federation's 1994 Distinguished Advertising Educator Award.

Sandi Shackelford is one of the 37 South Carolina performing artists who comprise the South Carolina Arts Commission's Community Tour. The Community Tour Program supports the development and promotion of touring cultural activities. The Arts Commission selects a group of professional South Carolina artists each year to be part of the tour. Performances may be held at community organizations, festivals, college and university series, churches and service organizations; and may be booked through June 30, 1994.

Carolyn Cox was recently elected to the 1993-1994 Horry Cultural Arts Council (HCAC) board of directors. She also will chair the council's public information committee, which works to keep the public informed of cultural programs and the functions of the HCAC to promote the arts and cultural life of residents of Horry County and surrounding communities by providing resources, information, funding, program coordination and communication.
