# BOOKSTORE NEWS

Book Orders: Faculty! Please consider seriously the books you plan to use in Summer Sessions I & II. Keep in mind the price, the number needed, and who has to buy it. Summer orders are due April 1. Fall orders are due May 27.

<u>Desk Copies</u>: Desk copies should be ordered by each faculty member prior to the semester the book is to be used. It is not the responsibility of the Bookstore to order desk copies for faculty members. However, the Bookstore does have a form letter that the faculty may use. Also, the Bookstore does not issue desk copies!

Checks: The Bookstore cannot possibly handle the cashing of student checks. Checks are accepted for the amount of purchase only.

# REPORTING SICK AND ANNUAL LEAVE

It appears that faculty and staff are neglecting to report their leave time. May I remind you that the College serves students and the public; therefore, the working hours are scheduled to satisfy the needs of the department in which you work and to make certain that an adequate work staff is available when needed. Twelve-month employees work a regular scheduled work week of 37½ hours. This work week is normally Monday through Friday from 8:30 a.m. to 5:00 p.m. and strict adherence to these hours is required. All absences for faculty on a nine-month assignment shall be incorporated into the department head's monthly report.
