FACULTY-STAFF ACTIVITIES

Dr. Jim Rex was one of six trainers chosen by the state to prepare sixty public school administrators, master classroom teachers and college professors to utilize the first draft of the new state-wide observation/evaluation instrument designed to evaluate all student teachers and first year teachers. The training took place at Hickory Knob State Park.

On behalf of the State of South Carolina, Dr. Rex made two presentations at national conferences regarding recent South Carolina legislation regarding the preparation, certification, evaluation and employment of classroom teachers: American Association of Teacher Education (ATE) in Dallas, Texas and the American Association of Colleges for Teacher Education (AACTE) in Detroit.


