LIBRARY RECEIVES DONATION

Kimbel Library at USC-Coastal Carolina College has received a donation of \$3,000 from an Horry County citizen, college officials have announced.

Mrs. Kathryn Moore of Briarcliffe West in Myrtle Beach made the contribution to the college library, according Coastal Carolina College Chancellor Dr. Edward M. Singleton.

"We're grateful to Mrs. Moore for her support," says Chancellor Singleton, "and we're particularly pleased she chose to assist the college library program. In this time of declining state support for higher education, Coastal Carolina College greatly depends on private giving. Kimbel Library, which is the largest repository of library materials in the Waccamaw Region, will benefit significantly from Mrs. Moore's important contribution."

Mrs. Moore is a longtime resident of Horry County. She is active in the Theodosia Burr Chapter of the Daughters of the American Revolution, is a member of Trinity Episcopal Church and is active in the Grand Strand Hospital Auxillary and Associated Charities. At age 86, she recently returned from an extensive tour of Egypt.

"Coastal Carolina College is such a great thing," she says. "It's an attractive campus with friendly people and I believe it's going to continue to grow. I think a library is essential to higher education. A library needs books, documents, manuscripts and such. I'm sure the library at Coastal is important to the college and I'm glad I could provide some assistance."

Mrs. Moore is the widow of the late Raymond C. Moore, who was a retired accountant living at Myrtle Beach. One of her sons, Myrtle Beach area realtor Don Moore is a member of the Horry County Higher Education Commission. Another son, Richard Moore, an retired USAF colonel, is a physicist.

ARTS ADVISORY GROUP FORMED

An Arts Advisory Group for Wheelwright Auditorium has been created at Coastal Carolina College.

The council was created to advise and coordinate operations policy for Wheelwright Auditorium, the first center for the performing arts in the Waccamaw-Grand Strand area. Members are: Col. CHANGES IN PAYCHECKS

Some notes from the Faculty Welfare and Development Committee concerning changes in the first paycheck of 1982:

The pay raise will not be compounded. It is based on last year's (1980/81) salary, not on your salary as of the Oct. increase.

This pay raise will not affect any insurance deductions, including life insurance.

FICA and Social Security WILL change by an increase of 50 cents per \$1,000 gross.

The S.C. Retirement System will drop from 6% to 4% (as usual when earnings exceed first \$4,800). This change will result in an increased take-home pay of \$19.50 more per \$1,000.

Federal and State income tax deductions are based on the same tables as last fall's. Federal tables will change on July 1, 1982 by a reduction of 10%.

USC will not implement any IRA accounts, however, there are several financial institutions offering these plans for individual planning.

MBAFB Credit Union is offering IRA accounts at a \$100 minimum with a Cross ball point pen as a premium.
