I. Call to Order

Oran Smith brought the meeting to order at 12:00 p.m. and stated that Chairman Wyatt Henderson was flying with the football team to North Dakota State for the NCAA quarterfinals.

II. Approval of Minutes

Larry Biddle to approve the October 11, 2013, and Carlos Johnson seconded. The motion carried.

III. President's Report

Greg Thornburg reported that the one-stop shop for recruitment and counseling has moved to Baxley Hall. It is a showplace. Spring 2013 enrollment was 7,490 and Spring 2014 is 7,504.

Nelljean Rice, Dean of University College, reported that University College is the newest college on campus and is designed to assist first-year undeclared students in their transition from high school to college and includes Interdisciplinary Studies majors, Honors Students, and Student Veterans. Academic coaching is available for students to be helped one on one. We now have an advisor for undeclared students. The Interdisciplinary Studies program allows students to combine two or more interests into a college degree. Students are highly encouraged to participate in internships. University 105 is a non-credit class training students how to study. The College has two new faculty members.

Rice introduced Jamie Jones, Andrea Robinson and Alison McQuarrie, students in University College, who shared their experiences.

Jones, B.S. in Environmental Science and Sustainability, had an opportunity during her senior year to have experiences in three different fields of study. She has networked with people in every corner of campus. She taught in the local Montessori School with Dr. Pamela Martin. As a result she has signed to teach in a school in South Korea. She finally found her niche and found confidence for her life study in only one year.

Allyson, B.A. Communications and Human Sciences, is a single mother and paramedic. After obtaining her associates degree from Horry-Georgetown Technical College, she transferred to Coastal Carolina University to get a degree in biology. She has decided to study to become a physician's assistant. Although there was not a curriculum available at CCU, she and Rice developed an interdisciplinary program that will allow her to qualify for several schools in the southeast. She has concentrated on human biology and science with a minor in health promotions. An internship at Coastal Orthopedics was very helpful.

Robinson, B.A., Law and Sociology, transferred from HGTC thinking that she wanted to be a paralegal. However, she discovered that she absolutely hated it and decided she wanted to go to law school. Her classes transferred over from HGTC. Interdisciplinary Studies was a blessing, allowing the opportunity to pick and choose classes. In the end, she discovered that she loved sociology. Tomorrow she graduates and already has a job with developer in the area.
