Chairman Delan Stevens called the Board meeting to order at 9:34 p.m. Roll call was taken by, Travis Overton, Chief of Staff.

President Michael Benson provided an overview regarding University operations on the impact of the Supreme Court decision that would permit a state of South Carolina higher education institution to implement a mask mandate. President Benson shared that language has been developed to implement an indoor mask mandate for the campus for all individuals.

Trustee George Mullen requested that a timeframe be placed on the mandate and that classes remain in person.

- **Gene Spivey moved to endorse the indoor mask mandate with a timeframe of four weeks to re-evaluate the mandate. Jason Repak seconded. A roll call vote was conducted and the motion carried. Noted for the record: Trustee Mullen voted no and Trustee Sherry Johnson abstained from voting.**
