COASTAL CAROLINA COLLEGE AWARDED EQUIPMENT GRANT

The Department of Energy, Richland Operations Office, has awarded the Energy-Related Laboratory Equipment Grant to Coastal Carolina College. The proposal was submitted by Dr. S. Ballou Skinner, professor of physics. The grant consists of 102 pieces of equipment with a total book value of \$77,026. Department of Energy Officials have said the grant is the largest ever awarded under this particular program to one institution. Most of the equipment is electronics, ranging from oscilloscopes to meters and analyzers. "The granted equipment will greatly strengthen our physics program by allowing our students the opportunity of working with sophisticated equipment that smaller colleges have difficulty in purchasing," said Dr. Skinner. "The equipment will greatly enhance our electronic analysis. Both science and non-science majors, as well as faculty, will be using the granted equipment."

MEMORANDUM FROM PRESIDENT HOLDERMAN

"The University of South Carolina System is committed to a policy of Affirmative Action/Equal Employment as published in the University's Policies and Procedures Manual.

Overall responsibility for implementation and compliance with the Affirmative Action Program is mine as President; however, it shall be not only the policy of the University, but also the practice of its administrators and hiring supervisors to recognize the rights of all employees and applicants for employment to be free from unlawful discrimination on the basis of race, sex, age, color, religion, national origin, handicap or veteran status."

NEH SUMMER STIPENDS

The NEH Summer Stipend program provides support for college and university teachers who are working in the humanities to pursue two consecutive months in full-time study or research. The proposed project may be one that can be completed during the stipend period, or it may be part of a long-range project. Application deadline is Sept. 24. Deans are reminded to submit the "Priority Form" to the committee, even if there is only one proposal from your school.

FARSOLAS AWARDED GRANTS

Dr. James J. Farsolas, associate professor of history at USC Coastal Carolina College, has been awarded a \$1,000 grant from the University of South Carolina on recommendation of the Research and Productive Scholarship Committee. The title of Dr. Farsolas' project is "A South Carolinian in the Court of St. Petersburg: Henry Middleton's Diplomatic Correspondence, 1820-1830." Dr. Farsolas plans to compile a documentary diplomatic history dealing with Russian-American relations of the 1820's, specifically the documents of Middleton, who was the U.S. minister to the Court of St. Petersburg, Russia. Dr. Farsolas earlier has received a travel grant to the Fifth International Congress of Southeast European Studies, which was to be held in Belgrade, Yugoslavia from Sept. 11-17. Dr. Farsolas was to present a paper at the Congress dealing with Greek-Serbian relations in the 19th Century. The paper also was to be published in the professional journal, Slavica. The travel grant was made with funds provided to the Joint Committee on Eastern Europe Council by the National Endowment for the Humanities for the Ford Foundation.
