BOARD OF TRUSTEES APPROVES TUITION INCREASE

The USC Board of Trustees has approved a \$100 tuition increase for Coastal Carolina College. The increase will bring semester tuition to \$700 for South Carolina students and \$1470 for out-of-state students. Part-time students will pay \$58 per hour while out-of-state part-timers will pay \$116.

Increases were also approved for the other four-year campuses in the University System.

ARCHITECT SELECTED FOR RESIDENCE HALLS

The Board of Trustees has selected the Myrtle Beach firm of Timbes, Wilund, Usry, and Carter Architects, Inc. to handle the residence halls project at Coastal.

The firm, which did preliminary work on residence halls for the Coastal Educational Foundation in 1984, also designed the addition to the Physical Education Center and the Baseball Stadium.

Chancellor Eaglin said he is pleased the college will be working with the firm again. "They have done excellent work for the college in the past, and we know their design will blend aesthetically with the other buildings on campus."

Plans call for the residence halls to be completed and ready for occupancy at the start of the fall 1987 semester.

COASTAL CAROLINA PEOPLE

o DR. RICHARD DAME, professor of marine science, has spent May and June as an invited scientist at the Rijkes Institute for Nature Management on the Island of Texel in The Netherlands. Dr. Dame was collaborating with Dutch scientists in determining the role of mussels in controlling water quality in the Dutch Wadden Sea. Dr. Dame was asked to adapt a technique he developed at USC's Baruch Institute near Georgetown for measuring the uptake and release of materials by oysters to mussel beds in Holland.

Also while in Holland, Dr. Dame was an invited speaker at the Netherlands Institute for Sea Research in Texel, the Rijkeswaterstaat Laboratory in Middleburg, and the Delta Institute for Hydrobiology in Yserke. Dr. Dame spoke on the role of filter feeders, particularly oysters, as controllers of estuarine nutrient cycling. The results of Dr. Dame's collaborative work will help the Dutch better manage their coastal waters and mussel industry and provide additional evidence on the functional significance of filter feeders in coastal waters worldwide.

o DR. DOUGLAS NELSON, professor of marine science, received a research contact from the Army Corps of Engineers to conduct a beach survey July 4. However, this survey was not the type that determines beach erosion. It was to count people in five two-block long sections of the beach between Cherry Grove and Garden City from 9 a.m. to 6 p.m. The study employed five students to help the Corps of Engineers determine how many people use the beach. This is one part of the evaluation of the beach being made by the Corps to justify, economically, the protection and renourishment of beaches.

o THOMAS E. JONES, director of the Wheelwright Performing Arts Center, has just returned from Greenville where he served as a judge for the 1986 Miss TEEN Pageant. This is the third year he has served in this capacity. Forty-nine young women from throughout the state participated in the week-end competition, and four young women from the Grand Strand area were among the contestants. The competition is based on scholarship, community service, talent, interview, and formal presentation.

o DR. ROBERT SQUATRIGLIA, associate chancellor for student development, has been appointed to the national program committee for the 1987 American College Personnel Association and National Association Student Personnel Administrator's joint conference. The national conference, scheduled for March 15-17 in Chicago, will be a joint celebration of the golden anniversary of the 1937 Student Personnel Point of View. Dr. Squatriglia will be one of 12 committee members responsible for selecting conference programs.

NASPA and ACPA include every college and university in the nation as members, and the 1987 conference is the first combined national conference for these two groups in ten years.

MAZURKIEWICZ NAMED DIRECTOR OF COUNSELING SERVICES

Dr. Joseph P. Mazurkiewicz has been appointed director of counseling services effective July 14.

Dr. Marzurkiewicz holds the bachelor's and master's degree from Trenton State College and the Ph.D. degree from Louisiana State University. He served as assistant director of the counseling and testing center at the University of Southwestern Louisiana in Lafayette from 1982 to the present.

His previous service included counselor at the Our Lady of the Lake Regional Medical Center and Chemical Dependency Center; as a clinical specialist at Bonnie Brae School in Millington, New Jersey; as an adult basic education coordinator for the Opportunities Industrialization Center of Somerville, New Jersey; and as a Peace Corps Volunteer in the Marshall Islands.

He replaces the interim director, Dr. Danna Brissie, who has been appointed by Governor Riley to the newly created Board of Examiners for the Licensure of Professional Counselors, Associate Counselors, and Marital and Family Therapists of South Carolina. Dr. Brizzie will also continue her private practice at the Grand Strand Counseling Center.

JENNIE SAUSSY ELECTED CHAIRMAN
OF GEORGETOWN COUNTY HIGHER
EDUCATION COMMISSION

Jennie Parker Saussy (Mrs. George F. Saussy, Jr.) was recently elected chairman of the Georgetown County Higher Education Commission which supports the Georgetown Extension of USC Coastal Carolina College.

A member of the commission for three years, Mrs. Saussy has served as secretary for the last two. She chaired the committee that drew up the contract with USC Coastal Carolina College to run the extension in Georgetown.

"Georgetown County needs full community support for the Coastal Carolina College extension," Mrs. Saussy said. "So many of our young people have to work and do not have the time and energy to commute all the way to Coastal. So many of our older population need a convenient place to pursue new skills and improve and sharpen old ones. An easily available, strong academic program is essential for the balanced growth of Georgetown County."

Mrs. Saussy returned to college at Coastal Carolina College and completed her bachelor's degree in 1979. In 1982, at the age of 59, she received her master's degree in education from Coastal. She said that she had decided to continue her education because there were things she wanted to do in the community and she felt the education was necessary. Her academic background as well as her experience as an older college student have given her a great deal of insight into higher education. "You find out a lot about young people," she said, "when you go to school with them."

Mrs. Saussy has been active in

community affairs in Georgetown and the Waccamaw region and has served on many boards including the United Way. For several years, she chaired the Georgetown County Mental Health Association and was the chairman of organization for the South Carolina Mental Health Association.

She has been a full-time resident of Georgetown County for 20 years.
