Donald Hall, Poet And Author, To Conduct Writer's Workshop And Poetry Reading At Coastal

Poet and author Donald Hall, who has had numerous books of poetry and prose published since 1955, will conduct a writer's workshop at Coastal Tuesday, January 17, from 5:30 to 6:15 p.m. in the Fine Arts Little Theater. He also will present a reading of his poetry from 7:30 to 8:15 p.m. in the Fine Arts Little Theater. Both programs are free and open to the public.

Hall, a noted writer whose work has been featured in over 50 books and more than 43 periodicals and magazines, has been the recipient of numerous awards. Most recently, Hall received the prestigious National Book Critic Circle Award in the area of poetry for his book <u>The One Day</u>, published in 1988. He was also the recipient of the Lenore Marshall/ The Nation Award for his book of poetry, <u>The Happy Man</u> in 1987, served as poetry editor of *The Paris Review* for nine years, and has had approximately sixty broadcasts of poems, criticisms, interviews, etc., on the BBC Third Programme, Home Service and Television.

Born in Connecticut, Hall received his B.A. degree from Harvard in 1951 and completed his education at Oxford in 1953. He lives in New Hampshire with his wife and family.

Speeding in excess of posted limit.

1. By 1 - 9 mph., fine of \$15 - \$25 and 2 points.

2. By 10 - 14 mph., fine of \$25 - \$50 and 4 points.

3. By 15 - 24 mph., fine of \$50 - \$75 and 4 points.

4. By 25 or more mph., fine of \$75 - \$200 and 6 points.

Note: Court cost of \$18 will be added to the fine.

Driving under the Influence.

- 1. 1st offense: Fine of \$200 or imprisonment for not less than 48 hours nor more than 30 days and driver's license suspended for 6 months.
- 2. 2nd offense: Fine of \$2000 \$5000 and imprisonment for 48 hours to one year and driver's license suspended for one year.
- 3. 3rd offense: Fine of \$3500 \$6000 and imprisonment for 60 days to three years and driver's license suspended for two years.
- 4. 4th and subsequent offense: Imprisonment for one year 5 years and driver's license suspended on the 4th offense for three years and on the 5th and subsequent offense - permanent revocation.

Note: Court cost of \$18 and a breathalyzer charge of \$50 will be added to the fine.

<u>Note</u>: Upon conviction, within a ten year period, for fourth and subsequent offenses for Driving under Influence or Driving under Suspension, the vehicle driven during the offense must be forfeited at the time of arrest if the offender is the owner of record or a resident of the household of the owner of record.

Use of headlights.

Headlights (excludes use of parking lights), must be used:

1. From half an hour after sunset to half an hour before sunrise.

2. At any time when windshield wipers are in use as a result of inclement weather or environmental factors if persons or vehicles cannot be discerned at a distance of 500 feet or more.

The provisions of this section do not apply to instances when windshield wipers are used intermittently. Beginning January 1, 1989, a fine of up to \$25 will be imposed.

Penalties for Failure to Stop when Signaled.

Where the motorist willfully fails to stop when it would be reasonable for a driver to see or hear the signal from the Law Enforcement Officer, mandatory penalties provide that persons found guilty must be fined \$500 or imprisonment of not less than 90 days and at the discretion of the judge, the driver's license may be suspended a minimum of 30 days to a maximum of one year.

Operating an Uninsured Vehicle.

Any person knowingly operating an uninsured motor vehicle or knowingly allowing the operation of an uninsured motor vehicle faces the following penalties.

1. 1st offense: Fine of \$100 - \$200 or imprisonment for 30 days.

2. 2nd offense: Fine of \$200 and/or imprisonment for 30 days.

3. 3rd and subsequent offenses: Imprisonment for 45 days - six months.

Note: Upon conviction, the SCDHPT shall:

- 1. Suspend the driving privilege of that person.
- 2. Suspend all license plates and registration certificates issued in that person's name.

Failing to Stop for a Stopped School Bus.

For drivers of vehicles who do not stop from either direction for a stopped school bus with red lights flashing and wait until such flashing ceases and for those drivers who fail to stop for a stopped school bus on:

1. A two-lane highway.

2. A four-lane or multi-lane highway separated by a narrow gravel median or painted lines.

3. Or when overtaking a school bus which has red or amber signals actuated.

If convicted, a person is subject to a fine of \$100 - \$200 or imprisonment for not more than 30 days.
