State Insurance plans require certification for dependents ages 19 and over

Employees who want to maintain health, dental, and dependent life coverage for dependents 19 years old (up to their 23rd birthday), are responsible for providing proof that the child is a full-time student or is incapacitated. Documentation must be provided annually each fall as proof that a dependent is a full-time student. If a dependent will be 19 years old later this year, it is recommended the employee provide student status information by Nov. 1. Once documentation is established, the certification requirement is valid until fall 1992.

A Student Certification Form and official documentation, which includes the institution's name and indication of full-time status, must be completed, signed by the employee, and submitted to certify the student's status. Examples of full-time student status documentation can be from a validated student I.D. card, paid fee receipt, or a letter from the Registrar.

Subject: Campus Parking, 1991-92

With the beginning of a new academic year, we have received many questions about campus parking. We wanted you to have the following information as we earnestly seek your cooperation and understanding.

1. There are a total of 2105 parking spaces on campus, of which 245 are designated for faculty/staff and 1860 designated for commuting students. Residence Hall students are permitted to park only in the Residence Hall area, from 8:00 a.m. to 2:00 p.m., Monday through Friday. Commuting students may park in the Residence Hall parking lots at any time from 8:00 a.m. to 2:00 p.m., Monday through Friday.

2. For safety reasons, Chanticleer Drive from College Road to the Bookstore parking lot has been widened and re-striped. Unfortunately, 80 parking spaces were eliminated in the process, but the new Bookstore/Law Enforcement Building parking lot has a capacity of 185 spaces.

3. Parking (330 spaces) is available to faculty/staff and students in the paved parking lot located between the college baseball field and the soccer stadium. This parking lot has never been filled to capacity.

4. The E. C. Wall School of Business parking lots (capacity of 325) completion is projected for January, 1992 use.

5. Parking Decals: Faculty/Staff receive 1 free parking decal (first decal) while registration for additional automobiles is \$10.00 per decal for the year. Student decals are issued at \$12.00 per decal for the year; registration for additional automobile is \$3.00 per decal for the year.

6. Faculty/Staff are permitted to park in student parking places on an overflow basis in the event that existing faculty/staff spaces are not available. Vehicles with student decals which are parked in faculty/ staff parking places are ticketed, however. Tickets will also be issued to any vehicle illegally parked in handicapped spaces, fire lanes or other areas so designated as well as failure to register.

7. Any person desiring to appeal any traffic violation which he/she feels may have been given through error or without just cause, may do so within seventy-two hours after the time of issuance (Saturdays, Sundays, and Holidays excepted); otherwise, the right of appeal is forfeited. Appeals are heard first at the Law Enforcement and Safety Office and then a written appeal may be made to the Traffic Appeals Committee. Appeal forms are available at the Law Enforcement and Safety Office.

8. The Building and Grounds Committee of the Faculty Senate, comprised of students and faculty, will examine the allocation of parking spaces on the campus and make recommendations regarding the allocation of such spaces.

We ask your continued cooperation in complying with the parking regulations of the College for the safety and convenience of all concerned. As of this writing, 197 "first" decals and 29 "second" decals have been issued to faculty/staff and 1882 decals have been issued to non-residence hall students. Your cooperation and support related to parking is earnestly solicited and appreciated.
