Dr. Smith brought the meeting to order at 11:00 a.m.

Dr. Smith moved to approve the Academic & Student Affairs Committee minutes of February 26, 2010. Mr. Carter seconded, and the motion carried.

The Student Housing Foundation bylaws have been revised and the proposed change to add two trustees as voting members has been received by Ms. Hanna and Mr. Meacham for review.

Dr. Smith wanted to know when the University's dashboard indicators would be up and running. Dr. Sheehan reported that the hardware and software have been installed in Dr. DeCenzo's and his office. The indicators have been identified and Datatel training is taking place. Everything should be in place this summer. Eventually the indicators will be placed on the Web site.
