Chairman Wyatt Henderson brought the meeting to order.

Bill Biggs moved to approve the Executive Committee minutes of February 21, 2013. Larry Lyles seconded and the motion passed.

Larry Biddle presented a CINO pin designed by Josten's to be used as recognition from the Board of Trustees to anyone who has exhibited excellent character, courage and commitment to Coastal Carolina University--someone who displayed characteristics of a good Chanticleer. The pin could be presented to every honorary degree recipient, speakers, students who have exhibited these qualities, etc. It will be presented on a card framed to put on desk. The Board will fund the pins. Biddle noted that he has no affiliation with Josten's.

A committee could be created to bring forth candidates. He suggested presenting the first awards to alumnae Linda Courtney, Ann Blizzard and Phyllis Crumpler.

As there were legal, contractual and personnel issues, the committee moved into Executive Session. No action was taken.
