Chairman Wyatt Henderson brought the meeting to order at 3:00 p.m.

Gene Spivey moved to approve the Executive Committee minutes of July 18 and Larry Biddle seconded. The motion carried.

Henderson stated that he believes that the Audit Committee is no longer necessary and proposed making the audit part of the Executive Committee. He also recommended taking student life from Academic Affairs and creating a Student Affairs and Retention Committee.
