Dean and Vice President for Research and Emerging Initiatives Michael Roberts reported that a grant proposal has been submitted for \$200,000 to purchase equipment for the Science building through the National Science Foundation and awaiting news from the application.

A Fifth T Innovation Group is being established in Georgetown with the intent for local entrepreneurs who are creating new business ventures to receive support from the center. The opening has been delayed due to recent flooding. A manager for this facility is being interviewed.

The Conway Innovation Center and the Wall College of Business are working with businesses in Iceland to bring companies here.
