Chair Oran Smith brought the Academic Affairs and Retention Committee meeting to order at 8:34 a.m. Chair Smith gave the invocation.

Dalton Floyd moved to approve the October 22, 2020, Academic and Retention Committee meeting minutes. Eugene Spivey seconded and the motion carried.

**Floyd moved to bestow Distinguished Professor Emeritus and Emeritus Professor title requests for tenured faculty to be awarded upon retirement (Motion 20-AAR-07). Spivey seconded and the motion carried.**

Janice Black was awarded the title of Distinguished Professor Emeritus at the time of her retirement.

**Floyd moved to approve the request for appointment of Professor of History with Tenure (Motion 20-AAR-08). Spivey seconded and the motion carried.**

**Academic Affairs and Retention Committee**  
**December 11, 2020**

President-elect Michael Benson's appointment of Professor of History with Tenure was approved.

Provost/Vice President for Academic Affairs, Daniel Ennis, presented the enrollment report. The fall 2020 enrollment is down, but the decrease is lower than anticipated. Freshmen applications for fall 2021 are currently down about 3% from last year.

Thus far, the recruitment process has been semi face-to-face with students due to COVID-19. The University has been dutiful in protecting employees and students. Yet, Coastal has learned a lot about COVID-19 and intends to get back on the road again this spring to meet students in person. The University has motivated admission counselors, and there is a plan to get more of them in the upstate and midlands for recruitment.

Chair Smith noted that Faculty Senate Chair, Brian Bunton, presented his Faculty Senate report via writing (attached).

As there was no additional business, Spivey moved to adjourn. Floyd seconded and the motion carried.
