(In accordance with the requirements of the South Carolina Freedom of Information Act, the news media were notified of the time, location, and agenda for the meeting. Three members of the media were in attendance: Katie Powell of MyHorryNews.com, Alan Blondin of The Sun News, and Hannah Strong of The Post and Courier.)

Chair Wyatt Henderson brought the meeting to order at 9:01 a.m.

Dalton Floyd moved to approve the October 22, 2020, Finance and Audit Committee meeting minutes. Sherry Johnson seconded and the motion carried.

Senior Vice President for Finance and Administration/Chief Financial Officer, David Frost, presented a general financial update. Frost stated that there was no change of information to the revenue report since the October Board of Trustees meeting. The University had planned for an 89% fall 2020 to spring 2021 conversion rate, and Coastal is pleased with the current status. Around \$6 million dollars has been added to payroll line items in order to accommodate this increase in students.

Regarding the CARES Act Fund, Greg Thompson, Associate Vice President of Finance and Controller, has submitted \$14.7 million dollars to Columbia for reimbursement. So far, \$7.4 million dollars has been reimbursed to the University. Of the current submissions, around \$4.2 million was for housing and other expenses incurred last year.

Chair Henderson noted what an amazing position the University is currently in considering the pandemic. The administration, faculty, and staff had to make hard cuts, and without these sacrifices, Coastal would not be in this incredible financial situation.

Johnson moved to request approval for renewal of a one-year lease with Fountain-Fuller of SC, L.L.C. for +/- 10,000 square feet of warehouse space at the Atlantic Center, (454 Century Circle), for University Housing, effective March 1, 2021, through February 28, 2022 (Motion 20-FAA-04). Floyd seconded and the motion carried.

Jason Repak moved for the University administration to request authority to exercise administrative discretion with regard to entering into four-month leases, each with a possible renewable term, with off-campus student housing properties near campus effective January 13, 2021, through May 13, 2021, for up to 100 beds (Motion 20-FAA-05). Floyd seconded and the motion carried.

As there was no additional business, Repak moved to adjourn. Lee Belcher seconded and the motion carried.
