Chairman Lee Belcher brought the meeting to order at 3:47 p.m.

Jason Repak moved to approve the Finance and Audit Committee meeting minutes from May 6, 2021. Patrick Sparks seconded, and the motion carried.

Senior Vice President for Finance and Administration/Chief Financial Officer, David Frost, presented a financial and audit update.

- There is no change in the budget projection for fiscal year 2022.
- There is a \$20 million dollar reserve for COVID-19 related expenses.
- State funding went up \$2.1 million dollars.
- The University budgeted a 2.5% cost-of-living increase for faculty and staff.
- Final audit field work should conclude at the end of August (2021).

Repak moved to approve and adopt the 30% tuition reduction for graduate-level coursework for employees of Horry-Georgetown Technical College (Motion 21-FAA-19). Sparks seconded, and the motion carried.
