Chairman Oran Smith called the Academic and Retention Committee meeting to order at 1:18 p.m.

Lisa Davis moved to approve the Academic Affairs and Retention Committee meeting minutes from Feb. 17, 2022. Dalton Floyd seconded, and the motion carried with no objections.

The following motions were presented for approval:

Davis moved to approve new program: B.S. in Mathematics Education. (Motion 22-AAR-04) Floyd seconded, and the motion carried.

Floyd moved to approve new program: B.A. in History Education. (Motion 22-AAR-05) Davis seconded, and the motion carried.

Floyd moved to approve the title of Distinguished Professor Emeritus for retiring faculty. (Motion 22-AAR-06) Davis seconded, and the motion carried.

The following professors will be bestowed title of Distinguished Professor Emeritus at the

time of their retirement: J. Ralph Byington, J. Kay Keels, James Luken, and John Goodwin.

Davis moved to approve administrator appointment with tenure. (Motion 22-AAR-07) Floyd seconded, and the motion carried.

Floyd moved to approve the amendment to the Faculty Manual to require the five most recent years of documents as part of a Lecturer's application for Senior Lecturer. (Motion 22-AAR-08) Davis seconded, and the motion carried.

Floyd moved to approve the amendment in the Faculty Manual to allow Senior Lecturers serving on college promotion and tenure committees to consider post-promotion review applications for Senior Lecturers. (Motion 22-AAR-09) Davis seconded, and the motion carried.

Associate Vice President for Enrollment Management, Amanda Craddock, presented a report on current enrollment.

- Currently an increase of 6.6% from this time last year for freshmen enrollment. Will continue to work on this, especially in-state numbers, over the summer months.
- Transfer numbers are lower right now. This is a national trend as there has been a decline in enrollment in community colleges as well. The numbers are still early and applications are still open over the summer. Updated numbers will be shared in the August meeting.

Vice President for Student Success, Enrollment Management and Student Affairs, James Solazzo, presented a report on retention.

- 84.4% of current students are enrolled for the fall semester.
- Preliminary numbers were presented for freshmen fall 2020 to fall 2021 retention; the numbers will continue to fluctuate through the summer.

Executive Vice President for Academic Affairs/Provost, Daniel Ennis, presented the Academic Affairs Report .

• Gave an overview of the new project/dashboard that has been launched, Tableau Data Dashboards. It pulls information from the University's database and gives live numbers, trends, etc., at any given time.

As there was no additional business, the meeting adjourned at 2:01 p.m.
