Associate Vice President for Enrollment Management, Amanda Craddock, reported on current enrollment.

- Freshmen enrollment: Up 5.7%.
- Continuing student enrollment: Up 3.2%.
- Total enrollment (with transfers): Down 0.1%.

Executive Vice President for Academic Affairs/Provost, Daniel Ennis, reported on retention.

- Fall 2021 – Fall 2022 Retention: Down 71%
 - 1% lower than last year
 - Reviewing data to determine why trending down and to see where changes can be made.

Vice President for Student Affairs, Yvonne Hernandez Friedman, reported on Student Affairs.
