William Turner moved to approve the Facilities and Planning Committee meeting minutes from Aug. 11, 2022. Mark Kelley seconded, and the motion carried.

Senior Vice President for Finance and Administration/Chief Financial Officer, David Frost, reported updates on capital projects.

- University Libraries:
 - Thompson Library construction is progressing and has an expected completion date of January 2024.
 - Kimbel Library renovation will begin once Thompson Library is complete.
- Soccer Complex:
 - Field lighting project was advertised and lowest bid was selected.
 - Following completion of the lighting project, a determination will be made on funds available to build the stands and stadium.

- Eaglin Hall: Replacement of telecommunications system and fire alarm system will begin summer 2023.
- Edwards Building: Bidding on roof project will begin in November 2022.
- Prince Building: Bidding on HVAC project will begin in October 2022.
- University Boulevard:
 - A civil engineering firm has been selected.
 - Programming committee kickoff was held in September 2022.
 - Phase I design expected to be complete in December 2022.
 - Phase II approval process will begin in February 2023.
- Indoor Practice Facility:
 - Architectural firm has been selected.
 - Advertisement for construction manager was posted in September 2022.
 - Phase I design expected to be complete in March 2023.
 - Phase II approval process will begin in May 2023.
- PGA Golf Management Program Learning Lab:
 - Architectural firm has been selected.
 - Preliminary layouts were presented to programming committee.
 - Phase I design expected to be complete in December 2022.
 - Phase II approval process will begin in March 2023.

Capital Project Review

- **Kelley moved to approve upgrading the campus WiFi network and replace outdated hardware to provide improved service to students, faculty, staff, and campus visitors (Motions 22-FAC-05). George Mullen seconded, and the motion carried.**
