Lease Review

- **Repak moved for the approval of a one-year lease, renewable for three more years, with Fountain Fuller of SC, L.L.C., for approximately 10,000 square feet of warehouse space at the Atlantic Center (454 Century Circle) for University Housing effective March 1, 2023, through February 29, 2024 (Motion 22-FAA-21).
